RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL  
OF THE OGLALA SIOUX TRIBE  
(An Unincorporated Tribe)

RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL DEEMS THE STIRK TABLE SITE AS THE SITE TO DEVELOP THE LAKOTA HERITAGE EDUCATION CENTER FOR THE SOUTH UNIT OF BADLANDS NATIONAL MONUMENT.

WHEREAS, the Oglala Sioux Tribe was organized under Section 16 of the 1934 Indian Reorganization Act by adopting a federally approved constitution and by-laws, and

WHEREAS, Article IV, Section 1(a) of the Tribal Constitution authorized the Tribal Council "to negotiate with the Federal, State, and local governments on behalf of the Tribe", and "to advise and consult with the representatives of the Interior Department on all activities of the Department that may affect the Pine Ridge Reservation", and Article IV, Section 1(m) empowers the Tribal Council "to protect and preserve the property, wild life and natural resources of the tribe", and

WHEREAS, the Oglala Sioux Tribe wishes to support the Stirk Table Site as the location for the future Lakota Heritage Education Center, and

WHEREAS, under an on-going process of site selection, the Oglala Sioux Land and Natural Resources has deemed this site to be the most conducive to attaining all of the planning efforts of the Oglala Sioux Parks and Recreation Authority, Tribal public input and past studies, now

THEREFORE BE IT RESOLVED, that the Oglala Sioux Tribal Council does deems the Stirk Table Site as the location for the Lakota Heritage Education Center for the South Unit of Badlands National Park, and

BE IT FURTHER RESOLVED, that the Oglala Sioux Tribal Council does hereby approve that all on-going development work can begin on this site as well as funding identification at the federal level.
